Sikander Lalani is a member of the ICCRC, the National Regulator of Immigration consultants in Canada. The Canadian Government authorizes only those immigration consultants who are Members in good standing of the ICCRC. With the coming into forces of Bill C-35, on June 30, 2011 anyone who provides paid advice prior to the filling of an application or the commencement of a proceeding must be an authorized representative. This means that some third parties who were not formally required to be recognized to provide paid advice will now have to refer people to an authorized representative or become authorized themselves. 

Express Entry is the selection system for Canadian immigration, designed to select skilled workers for immigration to Canada. It is a process whereby involving the federal government, provincial governments, and Canadian employers used to recruit skills from world over.

The Express Entry Process

All Express Entry candidates get a score out of 1,200, based on the four parts of the Comprehensive Ranking System formula.

Core/ Human Capital Factors -500/ 460

- 1. Age
- 2. Level of education
- 3. Official languages proficiency
- 4. Canadian work experience

Spouse or common-law partner factors = 40

- 1. Level of education
- 2. Official language proficiency
- 3. Canadian Work Experience

CRS = 1200

Skill Transferability factors = 100

- 1. Education
- 2. Foreign Work Experience
- 3. Cerificate of Qualification (Trade occupations)

Additional points = 600

- Canadian degrees, diplomas or certificates
 Valid iob offer
- 3. Nomination from a province or territory
- 4. Siblings living in Canada who is a citizen or PR
- 5. French language skills

Procedure Timeline

Educational Credential Assessment – Upto 4 months depending on the evaluating body

After Submission of Permanent Residence Application – Average processing time 6 months Application for Permanent Residence – To be submitted within 2 months from the date if Invitation to Apply (ITA) receiving
